THIS FLEXEQUITY MORTGAGE is made this 9th day of February 2002 by and between Frank J. Raymond and Nancy J. Raymond, Husband and Wife

(herein "Borrower") and GLENVIEW STATE BANK, an Illinois Corporation, whose address is 800 Waukegan Road, Glenview, Illinois 60025 (herein "Lender").

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated February 9, 2002 (herein "Note") with a credit limit of Fifty Thousand Dollars and no/100 dollars (\$ 50,000.00) (a minimum amount of \$10,000.00) of which an initial advance of XXXXXXXXXXXXXXXXXX XXXXXXXXXX XXXXXXXXXX has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The Note provides for monthly installments of interest or, if Borrower has elected to take any advance as a term loan, of principal and interest, at the rates set forth in the Note, with the principal balance of the indebtedness, if not sooner paid or required to be paid, due and payable five (5) years from the date hereof.

2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or to a waiver by Lender, Borrower shall pay to Lender on the day monthly installments of interest would be payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments which may attain priority over this Mortgage, and ground rents on the property if any, plus one-twelfth of yearly premium installments for hazard insurance; second, to the payment of any sums due under Paragraph 2 hereof; third, to the payment of interest and principal on any Future Advances; fourth, to the payment of principal of the Note; and then to interest and principal on any Future Advances.

**3. 
