#### NOW, THEREFORE, TO SECURE to Mortgagee:

- (a) The repayment of the indebtedness evidenced by the Lincoln Note and the Note, with interest thereon, and all renewals, extensions and modifications thereof;
- (b) The repayment of all indebtedness of Mortgagor, Van Gogh and Van Gogh Development to Mortgagee, howsoever evidenced;
- (c) The payment of all other sums, with interest, advanced in accordance herewith to protect the security of this Mortgage; and
  - (d) The performance of the covenants and agreements of Mortgagor herein contained;

TOGETHER with all buildings and improvements now or hereafter constructed upon said premises or any part thereof, all heretofore or hereafter vacated alleys and streets abutting said premises, and all fixtures and equipment located thereon or installed hereafter, said fixtures and equipment being pledged primarily and on a parity with said premises and which shall be deemed to be part of the premises to the extent they are permanently affixed thereto;

ordinances, regulations, orders and restrictions including, without limitation, all zoning, building code and environmental protection ordinances, regulations, orders and restrictions.

SECOND: Insurance: Mortgagor shall keep the premises and all buildings, improvements, fixtures and equipment now or hereafter thereon insured. The policies of insurance shall be in form, with insurers, and in such amounts as may be reasonably satisfactory to Mortgagee. Mortgagor shall deliver to Mortgagee the original (or certified) copy of each policy of insurance, or a certificate of insurance, and evidence of payment of all premiums for each such policy. Such policies of insurance shall contain a standard mortgagee clause naming Mortgagee as mortgagee thereunder as its interests may appear, and shall provide that the insurance companies will give Mortgagee at least thirty (30) days written notice before any such policy or policies of insurance shall be altered or cancelled and that no act or default of Mortgagor or any other person or entity shall effect the right of Mortgagee to be covered under such policy or policies of insurance in case of loss or damage. Mortgagor hereby directs all insurers under such policies of insurance to pay all proceeds payable thereunder to Mortgagee as its interests may appear and hereby authorizes Mortgagee to make, settle and adjust claims under such policies of insurance and endorse the name of Mortgagor on any check, draft, instrument or other item of payment for the proceeds of such policies of insurance. In the event of loss or damage, Mortgagee shall, after deducting the costs of collection thereof, if any, make the insurance proceeds available to l'Iorigagor for repair and restoration, provided:

- (a) The proceeds are deposited with Mortgagee;
- (b) There is no default under the terms of any of the Loan Documents (as hereinafter defined) which has not been cured within the applicable grace period;
  - (c) The insurance carrier does not deny liability to a named insured;
- (d) Mortgagee shall be furnished with an estimate of the costs of restoration accompanied by an architect's certification as to such costs and appropriate plans and specifications;
- (e) If the estimated costs of reconstruction shall exceed the proceeds available, Mortgagor shall furnish a bond of completion or such other evidence reasonably sa isfactory to Mortgagee of Mortgagor's ability to meet such excess costs;
- (f) Disbursement of the proceeds during the reconstruction shall be, in Mortgagee's discretion, through an escrow at a title company of Mortgagee's choice, or upon an architect's certification as to the cost of the work done and evidence that there are no liens arising upon the reconstruction. (g) Final payment shall be upon an architect's certificate and certification by one of Mortgagee's appraisers as to completion in accordance with plans and specifications.

The building and improvements so restored or rebuilt are to be of at least equal value and of substantially the same character as prior to the damage or destruction. In all other cases the proceeds of the loss under any policy shall be paid over to Mortgagee and shall be applied toward the payment of all amounts payable by Mortgagor to Mortgagee, whether or not then due and payable.

THIRD: Charges and Liens: Mortgagor shall pay when due all taxes and assessments that may be levied on said premises, and shall promptly deliver to Mortgagee receipts showing payment thereof. All reasonable amounts expended by Mortgagee hereunder shall be secured hereby and shall be due and payable by Mortgagor to Mortgagee forthwirk on demand.

FIFTH: Reimbursement for Mortgagee Legal Expenses: Should Mortgagee incur any cost or expense, including attorneys' fees, in enforcing its rights hereunder or in protecting the premises, whether or not any legal action is filed, or in the event that Mortgagee is made a party to any suit or proceeding by reason of the interest of Mortgagee in the premises, or if Mortgagee institutes proceedings to foreclose the mortgage granted hereunder, Mortgage' shall reimburse Mortgagee for all reasonable costs and expenses, including reasonable attorneys' fees, incurred by Mortgagee in connection therewith. All amounts incurred by Mortgagee hereunder shall be secured hereby and shall be due and payable by Mortgagor to Mortgagee forthwith on deman 1.

SIXTH: Acceleration: Should a default occur as specified in Paragrapi Six teenth herein or under the Note, or in the event judicial proceedings are instituted to foreclose a lier, upon the mortgaged premises or any part thereof, Mortgagee may at any time after such default, and without notice, declare the principal balance of the indebtedness secured hereby, together with interest thereon, to be due and payable immediately. The commencement of proceedings to foreclose this Mortgage shall, in any event, be deemed such declaration. Mortgagor to pay interest at a rate greater than is now lawful in such case to contract for, but shall require payment of interest only to the extent of such lawful rate, or (b) to require Mortgagee to make any payment or do any act contrary to law, and if any clause or provision herein contained shall otherwise so operate to invalidate this Mortgage, in whole or in part, then such clauses and provisions only shall be held for naught as though not herein contained and the remainder of this Mortgage shall remain operative and in full force and effect, and Mortgagee shall be given a reasonable time to correct any error.

THIRTEENTH: Partial Releases: Mortgagee, without notice, and without regard to the consideration, if any, paid therefor, and notwithstanding the existence at that time of any inferior liens, may release any part of the premises or any person liable for any indebtedness secured hereby, without in any way affecting the liability of any party to the Note, this Mortgage or any other security given for the indebtedness secured hereby and without in any way affecting the priority of the lien of this Mortgage and way agree with any party obligated on said indebtedness herein to extend the time for payment of any part of all of the indebtedness secured hereby. Such agreement shall not, in any way, release or impair the lien created by this Mortgage, or reduce or modify the liability, of any person or entity personally obligated for the indebtedness secured hereby.

#### FOURTEENTH: Environmental Warranty:

- Mortgagor hereby represents and warrants to Mortgagee that neither Mortgagor nor, to best of Mortgagor's knowledge after reasonable investigation, any other person or entity, has ever caused or permitted any Hazardous Material (as hereafter defined) to be placed, held, located or disposed of on, under or at the premises or any part thereof, and that the premises have never been used by Mortgagor or, to the best of Mortgagor's knowledge after reasonable investigation, by any other person or entity as a temporary or permanent dump of storage site for any hazardous, toxic or dangerous waste, substance or material defined as such in (or for the purposes of) the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, any so-called "Superfund" or "Superlien" law, and shall include, but shall not be limited to, any substances, materials or wastes that are regulated by any local governmental authority, the State of Illinois or the United States of America because of toxic, flammable, explosive, corrosive, reactive, radioactive or other properties that may be hazardous to human health or environment, including petroleum products, asbestos and including any material or substances that are listed in the United States Department of Transportation Hazardous Material Table, as amended, 49 C.F.R. 172.101, or in the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, 42 U.S.C. subsections 9601 et seq., or the Resources Conservation and Recovery Act, as amended, 42 U.S.C. subsections 6901, et seq., or any other applicable governmental law or regulation imposing liability or standards of conduct concerning any hazardous, toxic or dangerous substances, waste or material, as now or at any time hereafter in effect.

FIFTEENTH: Warrant and Defense of Title: At the time of the execution and delivery of this instrument, Mortgagor is truly seized of the premises in fee simple, free of all liens and encumbrances whatsoever except for the lien of the Mortgage of the Superior Lien Holder. Mortgagor will forever warrant and defend the same against any and all claims whatsoever, and the lien created hereby is and will be kept a second position lien upon the premises and every part thereof subordinate only to the lien of the Mortgage of the Superior Lien Holder. Mortgagor shall pay when due all water charges, sewer service charges and all other amounts which might become a lien upon the premises prior to this Mortgage and shall, upon written request, furnish to Mortgagee duplicate receipts therefor.

#### SIXTEENTH: Default

  - (3) An "Event of Default" occurs under the Lincoln Note;
  - An "Event of Default" occurs under the Note; (4)
  - (5) An "Event of Default" occurs under the Guaranty dated November 27, 2001 executed by Mortgagor in favor of Mortgagee (the "Lincoln Guaranty");
  - An "Event of Default" occurs under the Guaranty of even date herewith (6) executed by Mortgagor in favor of Mortgagee (the "Guaranty");
  - An "Event of Default" occurs under the Junior Mortgage dated November 27, (7) 2001 executed by Van Gogh in favor of Mortgagee relating to the real estate commonly known as 2518-2544 N. Lincoln Avenue, Chicago, Cook County, Illinois (the "Lincoln Center Junior Mortgage");
  - An "Event of Default" occurs under the Junior Mortgage of even date (8) herewith executed by Mortgagor in favor of Mortgagee relating to the real

- estate commonly known as 4700 N. Ashland Avenue, Chicago, Cook County, Illinois (the "Ashland Junior Mortgage");
- (9) A petition under the Federal Bankruptcy Reform Act of 1978, as amended, or any similar law, state or federal, whether now or hereafter existing, is filed by or against Mortgagor, Van Gogh or Van Gogh Development which is not dismissed within forty-five (45) calendar days thereafter;
- (10) Mortgagor, Van Gogh or Van Gogh Development is unable to pay their respective debts as they become due;
- A trustee or a receiver is appointed for all or any portion of the premises or for Mortgagor, Van Gogh or Van Gogh Development for a substantial portion of their respective assets, and such trustee or receiver is not discharged within forty-five (45) calendar days thereafter;

- (15) A judgment creditor of Mortgagor, Van Gogh or Van Gogh Development obtains a lien on or possession of any part of their respective assets or of the premises by any means, which is not discharged or released within forty-five (45) calendar days thereafter;
- (16) A notice of lien, levy or assessment is delivered to Mortgagor van Gogh or Van Gogh Development or is filed of record, with respect to the premises or any part of their respective assets, by the United States or any department, instrumentality or agency thereof, or by any state, county, municipal or other governmental agency;
- (17) There occurs any material uninsured damage or destruction to the premises or any personal property located thereon;
- (18) Mortgagor, Van Gogh or Van Gogh Development fails to pay any indebtedness due to any third party and such failure shall continue beyond any applicable grace period, or Mortgagor, Van Gogh or Van Gogh Development suffers to exist any other event of default, by acceleration or otherwise, under any note, loan agreement, lease, mortgage or trust deed, contract for deed,

security agreement or other contractual obligation binding upon Mortgagor, Van Gogh or Van Gogh Development; or

(19) Mortgagor mortgages, grants or conveys the premises to any person or entity other than Mortgagee.

(This Mortgage, the Lincoln Note, the Note, the Lincoln Guaranty, the Guaranty, the Lincoln Center Junior Mortgage, the Ashland Junior Mortgage and any other documents evidencing or securing the Note are collectively referred to herein as the "Loan Documents").

- (b) Upon the occurrence of an Event of Default, the entire indebtedness secured hereby shall, at the option of Mortgagee, without notice to Mortgagor, become immediately due and payable, and, the entire, or at any time during the existence of any such default, Mortgagee may proceed to foreclose this Mortgage by judicial proceedings according to the statutes in such case provided, and any failure to exercise said option shall not constitute a waiver of the right to exercise the same at any other time. - extend or modify any then existing leases and make new leases, which extensions, modifications and new leases may provide for terms to expire, or for options to lessees to extend or renew terms to expire, beyond the maturity dates of the Lincoln Note or the Note and the date of issuance of a deed or deeds to a purchaser or purchasers at a foreclosure sale, it being understood and agreed that any such leases, and the options or other such provisions to be contained therein, shall be binding upon Mortgagor and all persons whose interest in the premises are subject to the lien hereof and to be binding also upon the purchaser or purchasers at any foreclosure sale, notwithstanding any redemption from sale, discharge of the mortgage indebtedness, satisfaction of any foreclosure judgment, or issuance of any cerdificate of sale or deed to any purchaser;
