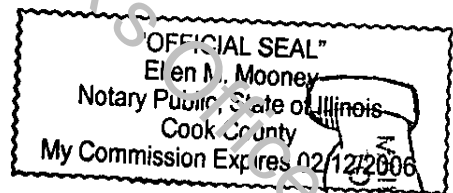
This Power of Attorney shall become effective upon execution by the undersigned and shall terminate on **May 17, 2002**.

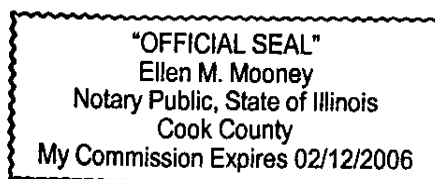
