

THIS MORTGAGE ("Security Instrument") is given on OCTOBER 26, 1998.
The mortgagor is American National Bank And Trust Company Of Chicago, Successor To Associated Bank-Gladstone, As Trustee Under Trust Agreement Dated April 2, 1990 And Known As Trust Number 1501 and not personally ("Borrower"). This Security Instrument is given to Associated Great Northern Mortgage Co., which is organized and existing under the laws of the State of Illinois and whose address is 2850 West Golf Road, Suite 403, Rolling Meadows, IL 60008 ("Lender").
