EXHIBIT A

Legal Description

Parcel 1: That part of Lot 1 in Block 4 in Highlands, being a Subdivision of the Northwest 1/4 and the West 800 feet of the North 144 feet of the Southwest 1/4 of Section 7, Township 38 North, Range 12, East of the Third Principal Meridian, according to the Plat thereof recorded November 6, 1891, as Document Number 1569674 in Book 51 of Plats, Page 41, in Cook County, Illinois, lying Easterly of a line extended from a point in the South line of said Lot 1 that is 163.0 feet Northeast of the Southwest corner of said Lot 1 (as measured along the Southerly line of said Lot 1) and through a point in the Southerly line of Woodside Avenue that is the point of intersection of a line that is 185 feet Easterly (measured at right angles) from the Westerly line of said Lot 1 with the Southerly line of said Woodside Avenue and lying Westerly of a line that is 275 feet Easterly (measured at right angles) from the Westerly line of said Lot 1 in Cook County, Illinois.

Parcel 2: That part of Lot 1 (except the West 275 feet thereof measured at right angles to the Westerly line) in Block 4 in Highlands, being a Subdivision of the Northwest 1/4 and the West 800 feet of the North 144 feet of the Southwest 1/4 of Section 7, Township 38 North, Range 12, East of the Third Principal Meridian, according to the Plat thereof recorded November 6, 1891 as Document No. 1569674 in Book 51 of Plats, Page 41, in Cook County, Illinois, described as follows: Commencing at the Northwest corner of the above described tract for a point of beginning; thence Easterly a distance of 50 feet on the South line of Woodside Avenue, thence South on a straight line to a point on the Westerly line of the above described tract 75 feet Southeasterly from the Northwest corner of said tract thence Northwesterly 75 feet to the point of beginning, all in Cook County, Illinois.
