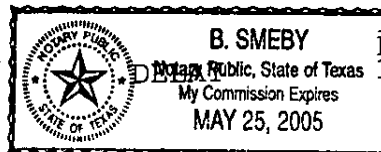

3. Legal Description:

THE EASTERLY 55 FEET (AS MEASURED ALONG THE SOUTHERLY LINE THEREOF) OF THE WESTERLY HALF OF THAT PART OF LOT 1 IN BLOCK 2 OF ELGIN HEIGHTS ADDITION TO ELGIN, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT IN THE EASTERLY LINE OF WRIGHT AVENUE 420.0 FEET NORTHERLY FROM THE SOUTHWEST CORNER OF LOT 11 IN BLOCK 2 OF SAID ELGIN HEIGHTS ADDITION; THENCE SOUTH 72 DEGREES 00 FEET EAST, 300.0 FEET TO A POINT ON THE WESTERLY LINE OF DICKIE AVENUE WHICH IS 370.0 FEET NORTHERLY FROM THE NORTHEASTERLY CORNER OF LOT 2 IN BLOCK 2; THENCE ON A CIRCUMFERENCE OF A SEMI-CIRCLE, WHOSE CENTER IS LOCATED ON A PERPENDICULAR LINE FROM SAID LAST POINT AT ITS INTERSECTION WITH THE CENTER LINE OF BLOCK 2, A DISTANCE OF 471.24 FEET TO THE PLACE OF BEGINNING, IN COOK COUNTY, ILLINOIS.
