## SUBORDINATION OF LIEN AGREEMENT

THIS SUBORDINATION AGREEMENT, made this 19th Day of March by ShoreBank an Illinois Bank in-Corporation.

#### WITNESSETH:

WHEREAS, James E. Cook and Lawayne S. WHEREAS, ShoreBank is willing to subordinate the priority of the ShoreBank prior lien in the Premises to the priority of the ShoreBank Lien in the Premises, pursuant to the terms and provisions contained herein,

NOW, THEREFORE, in consideration of the covenants and promises contained herein, ShoreBank agrees as follows:

- 1.) SUBORDINATION OF LIEN. This Agreement shall extend to and bind the respective successors and assigns of the parties hereto.
