JUDGMENT

This matter was heard on the petition of Jessica Appley and Defendant's response, due notice of the petition having been given, and the Court being fully advised;

IT IS HEREBY ORDERED THAT:

1. The Court finds that it has jurisdiction over the parties and the subject matter;
2. The Court further finds that the Petitioner, Jessica Appley, is the sole beneficiary of the estate of Mary Kochton Appley and is the actual bona fide owner of the judgment.
3. The Court orders that the Judgment rendered and entered by this Court in the case styled Mary Kochton Appley v. Stuart West, et al., Case No. 84 C 6025 on January 31, 1990, in Plaintiff's favor and against the Defendant, Stuart West, for total damages of \$495,000, plus costs and interest, is revived for the total amount of \$467,300, and in favor of the Petitioner, Jessica Appley and against the Defendant Stuart West.

4. The Court further orders that the Petitioner now recover from Defendant the total sum of the revived judgment of \$467,300, annual interest of 7.74 percent on the original judgment from January 31, 1990 through the date of this Order, annual interest of 7.74 percent on the revived judgment from the date of this Order until it is paid in full, costs of the original cause of action, and also Petitioner's costs in this action.
