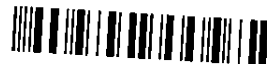

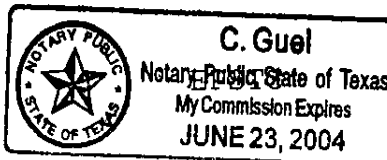

LEGAL DESCRIPTION
