The Illinois Department of Transportation right-of-way along those portions of Illinois Route 59 beginning at the boundary of Cook County and DuPage County and continuing north approximately 6.2 miles to Illinois Route 72 (Higgins Road), then continuing west approximately 1.8 miles along the right-of-way of Illinois Route 72 to Beverly Road, then continuing south approximately 1.0 miles along the right-ofway of Beverly Road to the intersection of Beverly Road and Interstate Highway 90, all in Cook County, Illinois, as shown on the attached drawings.

The right-of-way along those portions of Illinois Route 59 beginning at the boundary of Cook County and DuPage County in Section 33, Township 41 North, Range 9 East, and continuing north to Illinois Route 72 (Higgins Road), then continuing west along the right-of-way of Jinois Route 72 to Beverly Road, then continuing south along the right-of-way of Peverly Road through the following list of Sections, Townships, and Ranges, and ending at the intersection of Beverly Road and Interstate Highway 90, approximately 90 tect south of the north line of Section 5, Township 41 North, Range 9 East, all in Cook County, Illinois, as shown on the attached drawings.
