6. To-wit this affidavit is executed by an Assistant Vice President HOUSEHOLD FINANCE CORPORATION and the corporate seal of affixed.

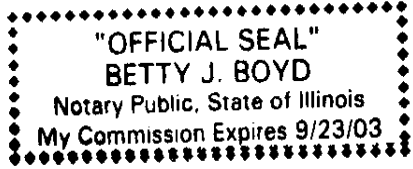
