As long as there is no default under the Note described above, the Mortgage securing the Note, the Construction Loan Agreement, this Agreement or any other present or future obligation of Borrower or Grantor to Lender ("Obligations"), or antor may collect all rents and profits from the Leases when due and may use such proceeds in Grantor's business operations. However, Lender may at any time require Grantor to deposit all rents and profits into an account maintained by Grantor or Lender at Lender's institution.
