Payments are deemed received by Lender when received at the location designated in the Note or at such other location as may be designated by Lender in accordance with the provisions in Section 15. Lender may return any payment or partial payment if the partial payments are insufficient to bring the Loan current. Lender may accept any payment or partial payment if the partial payment is insufficient to bring the Loan current. 




