9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. 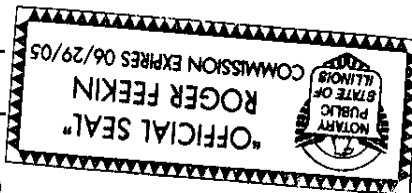
