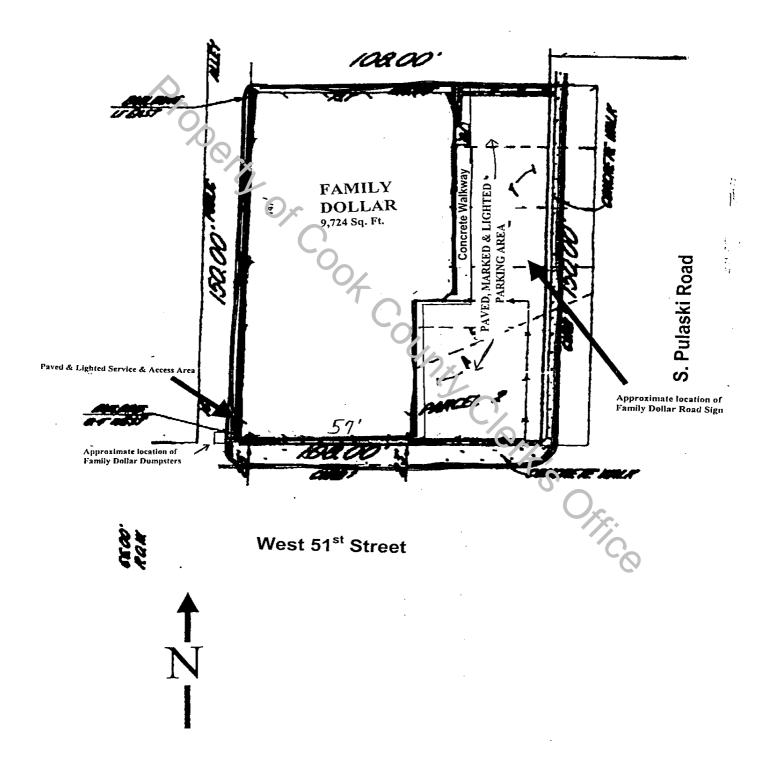


EXHIBIT B - SITE PLAN
