MEMORANDUM OF TERMINATION AGREEMENT OF INSTALLMENT AGREEMENT FOR DEED

This Memorandum of Termination Agreement of Installment Agreement for Deed ("Memorandum") is made as of Sactuation 6, 2001, by Joseph A. English, as beneficiary of Trust No. OP-011190 dated December 11, 1990 at First Chicago Trust Company of Illinois (hereinafter "Scaler") and Alfred John Lopez (hereinafter "Purchaser").

RECITALS

- 1. Seller and Purchaser entered into Installment Agreement for Deed dated June 12, 1991 ("Agreement"), pursuant to which Seller agreed to sell and Purchaser agreed to purchase certain property located in Cook County, Illinois, legally described on Exhibit A attached hereto and made a part hereof ("Property").
- 2. The Agreement was terminated as of September 6, 2001, pursuant to a Termination Agreement of Installment Agreement for Deed ("Termination Agreement").
