#### AMENDMENT TO FIRST MORTGAGE AND ASSIGNMENT OF LEASES AND RENTS

- A. Borrower has heretofore executed and delivered to Lender that certain First Mortgage, Security Agreement and Fixture Filing dated as of December 6, 2000 and recorded in the Cook County Recorder's Office on December 13, 2000 as document 12, 00977105 ("Mortgage"), providing Lender with a first mortgage lien on the real property legally described on Exhibit A attached hereto.
- B. Borrower has also executed and delivered an Assignment of Leases and Rents dated as of December 6, 2000 and recorded in the Cook County Recorder's Office on December 13, 2000 as Document No. 00977106 ("Assignent").
- C. - D. Borrower and Lender have executed a certain Loan Modification Agreement of even date herewith ("Modification Agreement") pursuant to which, among other things, the amount of the Loan has been increased to \$21,000,000.
