### **ATTACHMENT TO CERTIFICATE OF LIMITED PARTNERSHIP WEST MAYPOLE, LP**

9. The Partnership terminates upon the first to occur of December 31, 2103, the sale of all or substantially all of the property owned by the Partnership, agreement by all of the Partners to terminate, departure of the last general partner without substitution, or the happening of any event which makes it unlawful, impossible or impractical to carry on the business of the Partnership.

A Partner's transfer of his interest or any portion of his interest in the Partnership is subject to the right of first refusal provisions of the Partnership Agreement.
