IT IS HEREBY ORDERED that the defendant Kenneth G. Mick is in default for failing to appear, answer or otherwise plead.

IT IS FURTHER ORDERED that judgment is entered against defendant Kenneth G. Mick in the amount of \$173,297.46, and pre-judgment interest of \$2,906.39, for a total amount of \$176,203.85, plus court costs.
