Therefore, after all due credits, the amount left due, unpaid and owing to Claimant is \$371,722.70, for which amount, plus interest and collection costs, including reasonable attorneys' fees and costs, Claimant claims a lien against said property, and on any monies due or to become due to NOVAK or any other party for said project.
