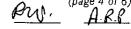
Property. Any action or inaction occurs that adversely affects the Property or Lender's rights in the Property. The term includes, without limitation, any substances defined as "hazardous material," "toxic substances," "hazardous waste," "hazardous substance," or "regulated substance" under any Environmental Law.

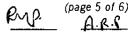
