EXHIBIT "A" DESCRIPTION OF COLLATERAL

- 1. All of the right, title and interest of the Debtor, if any, in and to all of the furniture, furnishings, fixtures, equipment, machines, apparatus, supplies and personal property, of every nature and description, and all replacements thereof and substitutions therefor, and the proceeds thereof now or hereafter located in or on the land and improvements legally described on Exhibit "B" attached hereto and made a part hereof ("Premises"), including but not limited to:
 - a). all furniture, furnishings and equipment furnished by the Debtor to occupants of the Premises;
