WITNESSETH, that the Grantor, for and in consideration of TEN AND 00/100 DOLLARS (\$10.00) and other good and valuable consideration in hand paid by the Grantee, the receipt whereof is hereby acknowledged, an pursuant to authority of the Board Directors of said corporation, by these presents does REMISE, RELEASE, ALIEN AND CONVEY unto the Granter, and to its successors and assigns, not in Tenancy in Common, but in JOINT TENANCY, FOREVER, all the following described real estate, situated in the County of Cook and State of Illinois known and described as follows to wit:



PARCEL 1: Unit 18519-2B & G-10 in the Harwood Court Condominium as delineated on a survey of the following described land: Lot 1 of Harwood Avenue Apartments resubdivision of Lots 17 to 32 inclusive in Block 6 and Lots 1 to 7 inclusive in Block 7; also the vicated portion of Elm Avenue lying between said Block 6 and 7; South of the South line of Willow Road; North of the North line of Heather Street and East of the Easterly line of Harwood Avenue; all in South Homewood, a subdivision of all of that part of the South ½ of the Northwest ¼ of Section 6.
