

## ASSIGNMENT OF LEASE AND MEMORANDUM OF LEASE

THIS ASSIGNMENT is made and entered into by and between CNL INCOME FUND XVII, LTD., a Florida limited partnership, having its office for business at 450 South Orange Avenue, Orlando, Florida 32801 (the "Assignor") and HARRIS TRUST & SAVINGS BANK, as Trustee under Trust Agreement dated February 1, 2002 and known as Trust #HTW 6018, c/o George Shepard, having his address at 930 Carriage Lane, Lake Bluff, Illinois 60044 (the "Assignee").

### WITNESSETH:

WHEREAS, Assignor, as seller, has agreed to sell, and Assignee, as buyer, has agreed to buy, that certain tract of land known as **200 Skokie Boulevard in the Village of Wilmette, Cook County, Illinois**, which land is described in that certain Lease Agreement between Assignor, as Landlord, and Vicorp Restaurants, Inc., a Colorado corporation, as Tenant, as evidenced by a Memorandum of Lease dated October 28, 1999, and recorded November 3, 1999, as Document No. 09035691, Official Public Records of Cook County, Illinois (the "Lease"); and

WHEREAS, concurrently with the sale of such land as aforesaid, Assignor desires to assign all of its right, title and interest in, to, and under the Lease; and

WHEREAS, Assignee desires to acquire Assignor's right, title and interest in, to, and under the Lease.

NOW, THEREFORE, in consideration of the sum of TEN DOLLARS (\$10.00) and other good and valuable consideration paid to the Assignor by the Assignee, the receipt and sufficiency of which is hereby expressly confessed and acknowledged, the Assignor does hereby assign, transfer, set over and convey all of its right, title and interest in, to, and under the Lease unto the Assignee, its successors and assigns. Assignor agrees to indemnify and hold Assignee harmless from and against any loss, damage, liability, cost or expense (including reasonable attorney's fees and court costs) accruing under or arising out of the Lease prior to the effective date hereof. Assignee agrees to assume the obligations of Landlord under the Lease from and after the effective date hereof and agrees to indemnify and hold Assignor harmless from and against any loss, damage, liability, cost or expense (including reasonable attorney's fees and court costs) accruing under or arising out of the Lease from and after the effective date hereof.
