

That on April 26, 2002, said contractor made a subcontract with the claimant to: (1) Rewire eight (8) unit building which consisted of six (6) apartments and two (2) store fronts. Work included new breaker panels; remove old wire from existing conduit replacing with new wire. Install one outlet on each wall and one switch per room. Install GFI's where applicable by code. Charge: nine (9) breaker panels with new twelve (12) positive panels. Rewire hallway and back porch. Total amount due Subcontractor: \$26,000.00

On June 11, 2002, the claimant completed said work and that balance due of \$8,672.00 was to be paid in full

That at the special instance and request of said contractor the claimant furnished extra and additional materials at no extra charge on said premises and completed it on July 2, 2002.

That said contractor is entitled to credits on account thereof as follows: \$5,000. 00 paid April 26, 2002, \$3,667.00 paid May 2, 2002, \$4,330.50 paid May 17, 2002, and \$4,330.50 paid June 6, 2002. Leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of Eight Thousand Six Hundred Seventy Two Dollars, (\$8,672.00) for which, without interest, the claimant claims a lien
