TRUST DEED MODIFICATION AGREEMENT

In consideration of the payment to PHILLIP V. PINELLO as Trustee of the Pin-Mer, Inc. Employees' Profit Sharing Plan, the owner and holder of the indebtedness described below, of a modification fee of Ten (\$10.00) dollars, receipt of which is hereby acknowledged, it is mutually agreed that the terms of repayment of said indebtedness and certain additional advances be and they are hereby modified as herein provided:
