OSB hereby constitutes and appoints any authorized CMMC officer its true and lawful attorney-in-fact, and in its name, place and stead and for its use and benefit, solely to execute incrtgage satisfactions, deed reconveyances, or similar lien release instruments, to the same extent that OSB could do itself, necessary to properly service the Mortgages prior to CHASE'S becoming mortgagee of record and for which CHASE is not in possession of an executed but unrecorded Assignment of Mortgage from OSB.

The undersigned gives any such authorized officer of CMMC, as attorney-in-fact, full power and authority to execute and/or endorse the above described docum in tion as if the undersigned were personally present, hereby ratifying and confirming all that said attorney-in-fact shall lawfully do or cause to be done by authority hereof.

This Limited Power of Attorney has been executed this 18 day of 2002, and the same shall continue in full force and effect until revoked in writing by the undersigned.
