8. Based on the foregoing, the decedent left as her only heirs, the following:



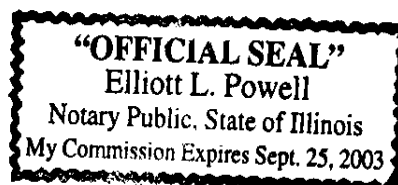
