Power of Attorney, made this 14 day of August, 2002

To refinance real estate located at:

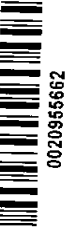
LEGAL DESCRIPTION:

 - My agent shall have the right by written instrument to delegate any or all of the foregoing powers involving discretionary decision-making to any person whom my agent may select, but such delegation may be revoked by any agent (including any successor) named by me who is acting under this power of attorney at the time of reference.
 - My agent shall be entitled to reasonable compensation for services rendered under this power of attorney.
 - This power of attorney shall be effective on Aug 15, 2002.
 - This power of attorney shall terminate on Aug 18, 2002.
 - If any agent named by me shall die, become incompetent, resign or refuse to accept the office of agent, I name the following (each to act alone and successively, in the order named) as successor(s) to such agent: None
- For purpose of this paragraph 8, a person shall be considered to be incompetent if and while the person is a minor or an adjudicated incompetent or disabled person or the person is unable to give prompt and intelligent consideration to business matters, as certified by a licensed physician.
- If a guardian of my estate (my property) is to be appointed, I nominate the agent acting under this power of attorney as such guardian, to serve without bond or security.
 - I am fully informed as to all contents of this form and understand the full impact of this grant of powers to my agent.

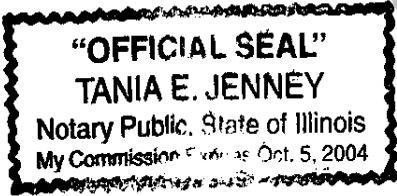

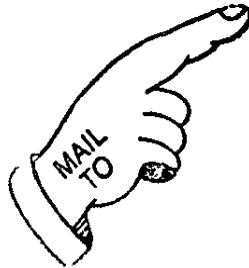
