Agreed Order

This case is before the Court on the Amended Motion to Enforce the terms of the Agreed Order entered May 3, 2002, between the plaintiff City of Chicago ("City") and Defendant Ricardo Garcia ("Defendant").

The parties wish to resolve this matter without a hearing and have read and agreed to the terms of this order. The Court makes the following findings of fact and law, and orders Defendant to comply with each of the agreements listed in this Agreed Order:

1. The Court has *in personam* jurisdiction over the parties and *in rem* jurisdiction over the properties at 4016-20 South Montgomery, Chicago, Illinois, ("properties") which is legally described as:

- 5. Defendant admits he is in violation of the Agreed Order entered May 3, 2002, because he did not provide proof to the City that a special use permit had been applied for until June 12, 2002.
- 6. Defendant agrees to pay a fine to the City in the amount of \$1000, by personally delivering or by mailing, a certified check or money order in the amount of \$1000, payable to the City of Chicago, to Tina Zvanja, at 30 North LaSalle, Suite 700, Chicago, Illinois 60602, no later than August 30, 2002.
- 7. This case is taken off the Court's call with the Court retaining jurisdiction to enforce the terms of this agreed order with a permanent injunction.
