The following is said ordinance as passed:

WHEREAS, Pursuant to Section 2-120-690 of the Municipal Code of Chicago (the "Municipal Code"), the Commission on Chicago Landmarks (the "Commission") has determined that the Washington Square District Extension, comprised of properties located at 22 -- 28 and 27 -- 31 West Chestnut Street and 802 -- 818, 827 -- 867, 1012, 1023 -- 1029 and 1150 -- 1154 North Dearborn Street and more precisely described in Section 2 hereof, is worthy of Chicago landmark designation; and

WHEREAS. The Commission has determined that the Washington Square District Extension meets four (4) criteria for landmark designation as set forth in Section 2-120-620 (1), (4), (5) and (6) of the Municipal Code and satisfies the historic integrity requirement set for it in Section 2-120-630 of the Municipal Code; and

WHEREAS, The Washington Square District Extension represents one of Chicago's oldest and most intact collections of masonry residences built for the city's elite, most of which were built in the 1870s and 1880s following the Fire of 1871; and

WHEREAS, The Washington Square District Extension contains residences owned and occupied by several of Chicago's most prominent families, including the Waller, Ryerson and DeKoven families; and

WHEREAS, The Washington Square District Extension includes one of the city's oldest, best and most intact collections of rowhouses and mansions in the Italianate style, the predominant architectural style in Chicago during the 1860s through early 1880s, and also contains high-quality examples of other popular nineteenth-century residential styles, including Second Empire, Victorian Gothic, Queen Anne, Richardsonian Romanesque and Georgian Revival; and

WHEREAS, The buildings found in the Washington Square District Extension feature elaborate ornamentation with a high degree of craftsmanship in details and materials, including finely-carved and incised window decoration and distinctive wooden and pressed-metal cornices; and

WHEREAS, The Washington Square District Extension includes buildings designed by many of the city's earliest architects, including Edward Burling, Dankmar Adler, William LeBaron Jenney, Frederick and Edward Baumann, Adolph Cudell, Samuel A. Treat, and Fritz Foltz, all of whom played a crucial role in the rebuilding of Chicago following the 1871 Fire; and

WHEREAS, The Washington Square District Extension displays a distinct visual unity based on a consistency of scale, building setbacks and landscaped front yards, design, size, use of building materials, and overall detailing, and ranks as one

WHEREAS, Pursuant to Section 2-120-690 of the Municipal Code, on July 11, 2001, the Commission adopted a resolution recommending to the City Council of the City of Chicago (the "City Council") that the Washington Square District Extension be lesignated as a Chicago landmark; now, therefore,

Be It Ordained by the City Council of the City of Chicago:

- SECTION 1. The acove recitals are hereby incorporated by reference as the findings of the City Council.
- SECTION 2. The Washington Square District Extension, including all of the properties described in Exhibit "A" and illustrated in Exhibit "B", is hereby designated as a Chicago landmar's in accordance with Section 2-120-700 of the Municipal Code.
- SECTION 3. The significant historical and architectural features of the Washington Square District Extension, for the purposes of Section 2-120-740 of the Municipal Code, are all exterior building elevations, including rooflines, visible from the public rights-of-way.
- SECTION 4. The Commission is hereby directed to create a suitable plaque or sign appropriately identifying said landmark and to install the plaque or sign in proximity to the properties designated as a Chicago landmark in accordance with the provisions of Section 2-120-700 of the Municipal Code.
- SECTION 5. The Commission is directed to comply with the provisions of Section 2-120-720 of the Municipal Code, regarding notification of said designation.
- SECTION 6. This ordinance shall take effect from and after the date of its passage.


