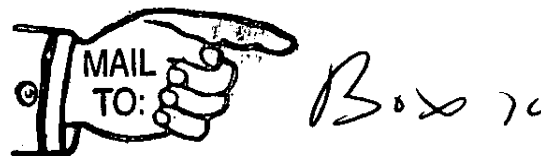
That on or about 12/11/2001, the owner owned the following described land in the County of **Cook**, State of Illinois to wit:
