#### SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS

THIS SFCURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS is made this 8th day of <u>August 2002, Redwood Development</u>, Inc and MCM Properties, Inc INC. (the "Mortgagor), to 1st SECURITY FEDERAL SAVINGS BANK (the "Mortgagee"), a national banking association, organized and existing under the laws of the United States of America, having its principal office at 936 N Western Ave, Chicago, IL 60622.

#### WITNESSETH:

WHEREAS, the Mortgager is indebted to Mortgagee in the total principal sum of Six Hundred Sixty Five Thousand and no/100 Dollars (\$665,000.00) or so much thereof as may be outstanding from time to time under a certain Promissory Loan Note dated August 8, 2002 from Mortgagor payable to the order of Mortgagee in the principal amount of \$665,000.00 (said note and all modifications, renewals or extensions thereof, the 'Note') plus interest in the amount as provided in and evidenced by the Note, which Note is incorporated herein by this reference.

NOW, THEREFORE, to secure (a) the payment of the indebtedness evidenced by the Note together with interest thereon (the "Indebtedness) and any fees in connection therewith, (b) the repayment of any advances or expenses of any kind incurred by Mortgagee pursuant to the provisions of or on account of the Note or this Mortgage, (c) the repayment of future advances, if any, disbursed by Mortgage to Mortgagor in accordance with the terms of the Mortgage or the Note in excess of the principal of the Indebtedness, and (d) the performance and observance of all of the terms, covenants, provisions and agreements of this Mortgage, the Note and all other documents now or hereafter executed in connection with the Indebtedness (collectively, the Loan Documents"), all of the foregoing not to exceed 200% of the principal amount of the Note, the Mortgagor agrees as follows

#### ARTICLE I (GRANT)

1.01 The Mortgagor hereby grants, bargains, sells, releases, conveys, assigns, transfers, mortgages and confirms unto the Mortgagee, and grants a security interest in, the real estate described in Exhibit A attached hereto and made a part hereof (the 'Real Estate'), which with the property, estates and interests never after described is referred to herein as the "Property';

Together with, all rents, issues, profits, royalties, income and other benefits derived from the Real Estate subject to the right, power and authority hereinafter given to Mortgagor to collect and apply such rents:

#### ARTICLE II REPRESENTATIONS

- 2.01 Mortgagor represents it has good and marketable title to the Property. - 2.02 Mortgagor recresents that the proceeds of the loan evidenced by the Note will be used for the purposes specified in 815 ILCS 205/4 of the Illinois Revised Statutes and that the principal sum evidenced by the Note constitutes a business loan which comes within the purview of such paragraph.
- 2.03 Neither Mortgagor nor, to the best of Mortgagor's knowledge, any previous owner of the Property or any third party, has used, generated, stored or cisp sed of any Hazardous Substances on the Property. For the purposes of this representation and warranty, Hazardous Substances shall include, but shall not be limited to, any toxic or hazardous wastes, pollutants or substances, in luding, without limitation, asbestos, PCBs, petroleum products and byproducts, substances defined or listed as hazardous substances or toxic substances or similarly identified in or pursuant to the Comprehensive Environmental Response, Con pensation and Liability Act of 1980, as amended, 42 U.S.C. a' 9601 et seq., hazardous materials identified in or pursuan, to the Hazardous Materials Transportation Act, 49 U.S.C. a' 1802 et seq hazardous wastes identified in or pursuant to The Resource Conservation and Recovery Act, 42 U.S.C. a' 6901 et seq, any chemical substance or mixture regulated under the Toxic Substance Control Act of 1976, as amended, 15 U.S.C. a' 2601 et seq, any toxic pollutant under the Clean W.e. Mortgagor hereby waives any and all rights of redemption under judgment of foreclosure of this Mortgage on behalf of Mortgagor, and on behalf of each and every person acquiring any interest in or title to the Real Estate or of any nature whatsoever subsequent to the date of this Mortgage. The foregoing waiver of right of redemption is made pursuant to the provisions of Section 15 160(B) of the Act. To the fullest extent permitted under applicable law, Mortgagor shall not, and will not, apply for or avail itself of any appraisement, valuation, stay, extension or exemption law, or so called "Moratorium Laws." now existing or hereafter enacted, in order to prevent or hinder the enforcement or foreclosure of this Mortgage, but hereby waives the benefit of such laws. Mortgagor for itself and all who may claim through or under it waives any and all right to have the Real Estate, and any estates comprising the Real Estate, marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Real Estate sold as an entirety.

- 4.01 Mortgagor covenants and agrees to pay the Indebtedness and the other sums secured hereby in the manner and at the times provided for in the Loan Documents.
  - 4.02 Mortgagor covenants and agrees to pay, or cause to be paid, when due and payable by Mortgagor:
  - (a) all real estate taxes, personal property taxes, assessments, license fees, water and sewer rates and charges, and all other governmental levies and charges, of every kind and nature whatsoever, general and special, ordinary and extraordinary, unforeseen as well as foreseen, which shall be assessed, levied, confirmed imposed or become a lien upon or against the Property or any portion thereof, and all taxes, assessments and charges upon the rents, issues, income or profits of the Property, or which shall become payable with respect thereto or with respect to the occupancy, use or possession of the Property, whether such taxes, assessments or charges are levied directly or indirectly (hereinafter collectively called the "Taxes"); and

Within ten (10) Ja's after written demand therefor, Mortgagor shall deliver to Mortgagee the original, or a photostatic copy, of the official receipt evidencing payment of Taxes or other proof of payment satisfactory to Mortgagee. Failure of Mortgagor to deliver to Mortgagee said receipts or to submit other proof satisfactory to Mortgagee as aforesaid shall constitute an Event of Default hereunder.

- 4.03 To assure payment of Taxes and insurance premiums payable with respect to the Property as and when the same shall become due and payable:
  - (a) The Mortgagor shall acposit with Mortgagee at the time of the disbursement of the proceeds of the Note:
  - (i) An amount equal to one twelfth of such Taxes due multiplied by the number of months (plus one additional month) elapsed between the date on which the most recent installment for such taxes was required to be paid and the date of such first deposit; and
  - (ii) An amount equal to one-twelfth of such annual insurance premiums multiplied by the number of months (plus one additional month) elapsed between the date premiums on each policy were last paid to and the date of such first deposit.

7.01 Mortgagor hereby assigns to Mortgagee all of Mortgagor's interest in all rents, issues and profits of the Property, as further security for the payment of the Indebtedness and other sums secured hereby. Mortgagor grants to Mortgagee the right to enter the Property and to let the Property, or any part thereof, and to apply said rents, issues, profits and proceeds after payment of all charges and expenses, on account of the Indebtedness and other sums secured hereby. This assignment and grant shall continue in effect until the Indebtedness and other sums secured hereby are paid in full. The assignment under this Article VII is given as a primary pledge and assignment of the rights described herein and such assignment shall not be deemed secondary to the security interest and Mortgage of Mortgagor in the Property. Mortgagor agrees that hereafter it shall not ascign any of the rents or profits of the Property.

  - (b) Nonpayment of principal under the Note when due, or nonpayment of interest under the Note or of any other obligations under any of the Loan Documents within five days after the same becomes due.
  - (c) The occurrence of a default by Mortgagor or any guarantor of any of the Indebtedness under any other Loan Document not remedied within any applicable cure period.
