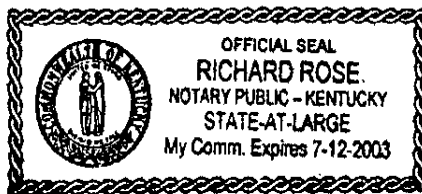

LEGAL DESCRIPTION

That part of the North 50 acres of the West 1/2 of the Northeast 1/4 of Section 4, Township 35 North, Range 13, East of the Third Principal Meridian, described as follows: Commencing at a point in the East line of said West 1/2, which is 497 feet South of the Northeast corner thereof, and running thence West of a line which is parallel to the North line of said West 1/2 a distance of 559.57 feet to a point which is 728.83 feet East of the West line of said West 1/2; thence Southerly a distance of 165 feet to a point which is 726.53 feet East of the West line of said West 1/2; thence East on a line which is parallel to the North line of said West 1/2 a distance of 591.87 feet to the East line of said West 1/2; thence North on said East line a distance of 165 feet to the place of beginning.
