In the event of such waiver, Borrower shall pay directly, when and where payable, the amounts due for any Escrow Items for which payment of Funds has been waived by Lender and, if Lender requires, shall furnish to Lender receipts evidencing such payment within such time period as Lender may require. These agreements may require the mortgage insurer to make payments using any source of funds that the mortgage insurer may have available which may include funds obtained from Mortgage Insurance premiums).

As a result of these agreements, Lender, any purchaser of the Note, another insurer, any reinsurer, any other entity, or any affiliate of any of the foregoing, may receive (directly or indirectly) amounts that derive from (or eight be characterized as) a portion of Borrower's payments for Mortgage Insurance, in exchange for sharing or modifying the moltgage insurer's risk, or reducing losses.
