TO MODIFY THE LOAN PROGRAM TO RESET INITIAL TERM ON AN ADJUSTABLE RATE (3/1); TO MODIFY THE INTEREST RATE FROM 7.375; TO 5.000%; TO MODIFY THE PRINCIPAL AND INTEREST PAYMENT FROM \$568.45 TO \$416.45; TO MODIFY THE ORIGINAL MORTGAGE TO ALLOW FOR AN ADDITIONAL ADVANCE OF FUNDS; AND TO FREVIDE AN ADDITIONAL ADVANCE OF \$575.00; TO EXTEND THE LOAN MATURITY DATE FROM JULY 1, 2030 TO JULY 1, 2032.

NOW THEREFORE, in consideration of the mutual covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

IT IS AGREED THAT AS OF THE DATE OF THIS MODIFICATION, THE UNPAID PRINCIPAL BALANCE OF SAID INDEBTEDNESS IS Seventy Seven Thousand Two and 62/100 DOLLARS (\$77,002.62).

THE NOTE AND MORTGAGE DATED 06/30/00 SHALL BE MODIFIED TO PROVIDE FOR AN ADDITIONAL ADVANCE OF FUNDS NOT TO EXCEED THE AMOUNT OF Five Hundred Seventy Five and No/100 DOLLARS (\$575.00).

MIDAMERICA WILL FU D W ADDITIONAL ADVANCE OF Five Hundred Seventy Five and No/100 DOLLARS (\$575.00) WHICH SHALL INCREASE THE UNIAID PRINCIPAL BALANCE OF SUCH INDEBTEDNESS TO Seventy Seven Thousand Five Hundred Seventy Seven and 62/100 DOLL/RS (\$77,577.62).

THE BORROWERS DO HEREBY AMIND AND MODIFY THE NOTE AND MORTGAGE DESCRIBED ABOVE BY SPECIFICALLY AMENDING CERTAIN SECTIONS RELATING TO INTEREST, FAYMENTS, ADJUSTALE RATE CHANGES, AND PREPAYMENT PENALTY (AS APPLICABLE) OF THE NOTE AS FOLLOWS:

AS OF 07/01/02, THE MODIFIED INTERES. LATE ON THE LOAN WILL BE 5.000%. UNTIL THE NEXT INTEREST RATE CHANGE DATE.

THE ADJUSTABLE INTEREST RATE MAY CHANGE ON 07/01/05, AND ON THAT DATE EVERY 12TH MONTH THEREAFTER. EACH DATE ON WHICH THE ADJUSTABLE RATE COULD CHANGE IS CALLED A "CHANGE DATE".
