A copy of said judgment is attached hereto as Exhibit "A."

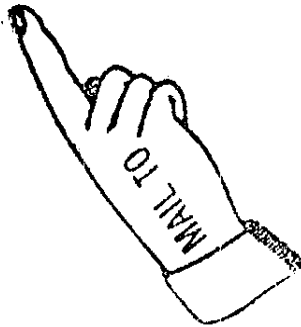
