Claimed: \$159,039.65 plus statutory interest

- 1. The Contract. Master Hand Contractors. Inc., an Illinois corp. (hereinafter "the Claimant"), has provided materials and labor for improvements to real property, described, infra, pursuant to a contract with the Owner of said property, to wit, 152 Cooper L.L.C. Said improvements include, but are not limited to, demolicion, tuckpointing, structural steel, HVAC, electrical, flooring, rough carpentry, concrete, plumbing, masonry, and ancillary work and materials.
- 2. <u>Performance</u>. The claimant performed the contract until the Claimant was wrongfully terminated by the Owner, or was otherwise excused from further performance. The last day of work at the real property was on or about **August 15**, 2002. The above described labor and materials were actually used and incorporated into the improvements to the real property, and constituted a substantial increase in the value thereof.
- 3. The Subject Property Described. The real property claimed against by the Claimant is commonly known as 152 4 W. Huron St., Chgo., Ill. 60610, bears Permanent Index Number 17-09-210-012-0000, and is legally described as:

PARCEL 2: an Easement for a party Wall as set forth in an Agreement dated January 7, 1914 and recorded February 25, 1914 as Document no. 536278 over the following described Land: 75 Feet in Width and extending from the rear Lot Line of the West in a Southerly direction 35 Feet, 4 Inches, all in Cook County, Illinois,

4. The Amount. The amount due to the Claimant due under the above described contract is \$159,039.65, plus 10% interest from the date the amount was due to the Claimant. The amount due PAGE 1 OF 1
