POWER OF ATTORNEY FOR PROPERTY



POWER OF ATTORNEY made this 20th day of August, 2002.





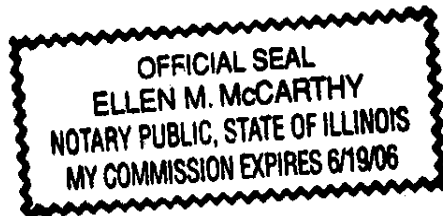
