The claimant, East-West Mechanical Contractors, Inc. - 2. On or about July 1, 2001, Owners entered into a written contract ("Contract"), wherein Claimant agreed to improve the Real Estate by furnishing the supervision, labor, materials and equipment necessary to, among other things: Rough in and install Owner's fixtures: (8) water closets, (8) lavatory sinks, (8) tubs and showers, (8) kitchen sinks and (8) floor drains; remove all pipe previously installed and; to run new 2" water service. Owner, Cleotha Carroll, agreed to pay \$10,000.00 before the job began, a second payment of \$8,400.00 as worked progressed, a third payment of \$8,460.00 as work further progressed and a final payment of \$8,400.00 upon completion of the job.
- 3. On July 24, 2607 Claimant also performed additional work in the amount of \$293.50 at the request of Owner to replace deteriorating soil stacks and branches on the East and West sides of the building with new soil pipe and copper branches.
- 4. On July 25, 2001, Claimant also performed additional work in the amount of \$923.00 at the request of Owner to fix (7) leaking soil stack joints on the East side of the building and (8) leaking soil stack joints on the West side of the building.
- 5. On July 25, 2001, Claimant also performed additional work in the amount of \$1,160.00 at the request of the Owner to remove existing soil stacks.
- 6. On July 27, 30 & 31, 2001 and August 1, 2 & 3, 2001, Claimant also performed additional work in the amount of \$12,041.80 at the request of the Owner to replace the main stacks.
- 7. On November 23, 2001, Owner was in material breach of contract by fa.ling to make timely and adequate payment to Claimant pursuant to the terms of the agreements referred to above.
- 8. Claimant has been paid the \$10,000.00 down-payment for the work that it performed under the Contract, and has credited the Owner's account in the amount of \$10,000.00.
 - 9. Claimant was also paid \$3,000.00 on November 23, 2001.

- Prior to the filing of this lien, Claimant gave a Special Discount of 25%, totaling 10. \$3,604.58, on the extra work not included in the contract, but performed at the request of buildingowner on the following dates: July 24, 25, 26 & 27, 2001; July 30 & 31, 2001; August 1, 2 & 3, 2001.
- As of the date hereof, there is due, unpaid and owing to Claimant, after allowing all 11. credits, the principal sum of \$33,013.72, which principal amount bears interest at the statutory rate of 10 percent per annum. Claimant claims a lien on the Real Estate (including all land and improvements agunt \$3.5, Collange Clerk's Office thereon) in the amount \$33,013.72 plus interest.
