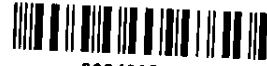



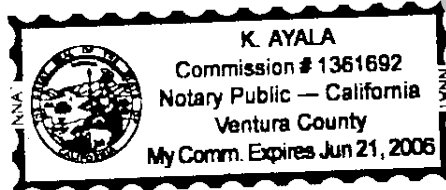

LEGAL DESCRIPTION:
