

Borrower's obligation to make such payments and to provide receipts shall for all purposes be deemed to be a covenant and agreement contained in this Security Instrument, as the phrase "covenant and agreement" is used in Section 9. 5. Property Insurance. 
If Borrower abandons the Property, Lender may file, negotiate and settle any available insurance claim and related matters. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the claim. The 30-day period will begin when the notice is given. Nothing in this Section 10 affects Borrower's obligation to pay interest at the rate provided in the Note.

Mortgage insurers evaluate their total risk on all such insurance in force from time to time, and may enter into agreements with other parties that share or modify their risk, or reduce losses. These agreements may require the mortgage insurer to make payment, using any source of funds that the mortgage insurer may have available (which may include funds obtained from Mortgage Insurance premiums).

The Borrower agrees that the Jender, at any time and without prior notice, may declare an event of default under the Security Instrument and a celerate all payments due under the Security Instrument and the Note under the following terms and conditions:

#### 1. Failure to Occupy

The Borrower agrees that the Lender may declare an event of default under the Security Instrument and accelerate all payments due under the Security in rument and the Note if the Borrower fails to occupy the Property without prior written consent of the Lender.

#### 2. Notice of Misrepresentation

The Borrower understands that the Lender has relied upon statements provided by the Borrower contained in the documents provided by the Borrower in support of the loan application in the processing, financing and granting of this loan.

Upon discovery of fraud or misrepresentation by the Borrower with respect to any information provided by the Borrower in the loan application or other documents executed in connection with the Note and Security Instrument, or if the Borrower omits or misrepresents a fact that is material with respect to the provisions of Section 143 of Internal Revenue Code of 1986, as amended, in an application for the loan secured by the Security Instrument, the Lender, in its sole discretion, by written notice to the Berlower may declare all obligations secured by the Security Instrument and all obligations payable under the Note mm diately due and payable and exercise any other remedy allowed by law or provided by the Security Instrument.

The Borrower shall notify the Lender promptly in writing of any transaction or event which may give rise to such a right of acceleration. If the Borrower fails to pay these sums prior to the expiration of this period, the Lender may invoke any remedies permitted by the Note or by the Security Instrument without further notice or demand on the Borrower.

#### 4. Restrictions on Transfer of Property

As long as this Security Instrument related to the Note is backing a FNMA Security or a FHLMC Security held by the Trustie for the mortgage revenue bonds issued by the City of Aurora, Kane, DuPage, Will and Kendall Counties, Illinois, the City of Rockford, Winnebago County, Illinois, and the City of Springfield, Sangamon County, Illinois jointly, (the "Issuers"), the unpaid principal balance of the Note may be declared immediately due and payable if all or part of the Property is sold or otherwise transferred by the Borrower to a purchaser or other transferee:

- (i) who cannot reasonably be expected to occupy the Property as a principal residence within a reasonable time after the sale or transfer, all as provided in Section 143(c) and (i)(2) of the Internal Revenue Code of 1986, as amended; or
- (ii) who has had a present ownership in erest in a principal residence during any part of the three-year period ending on the date of the sale of transfer, all as provided in Section 143(d) and (i)(2) of the Internal Revenue Code of 1986, as a mended (except that the words "100 percent" shall be substituted for the words "95 percent or mor;" where the latter appears in Section 143(d)(l); or
- (iii) at an acquisition cost which is greater than 90 percent of the average area purchase price (greater than 110 percent for targeted area residences), all as provided in Section 143(e) and (i)(2) of the Internal Revenue Code of 1986, as amended; or
- (iv) whose family income exceeds that established by the Issue's under their applicable Rules and Regulations in effect on the date of sale or transfer.
