

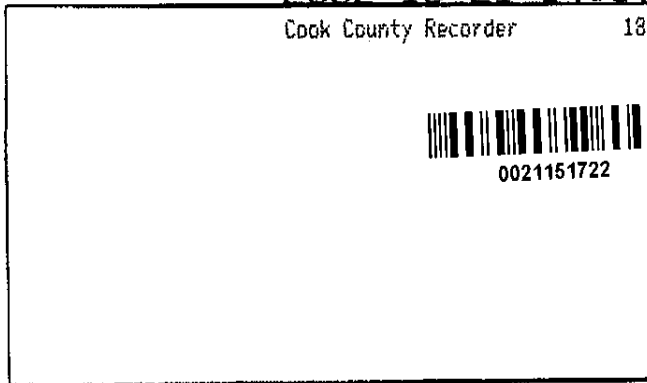

The claimant W.R. Weis Company, Inc. ("Claimant"), being a stone installation subcontractor, having its principal place of business at 2100 South Wabash Avenue, Chicago, Illinois, hereby files notice and claim for mechanics lien on the land described below and against the general contractor AMEC Construction Management, Inc., 125 South Wacker Drive, Suite 200, Chicago, Illinois 60606 ("General Contractor"), and One North Wacker Drive Venture, L.L.C., c/o/ The John Buck Company, 233 South Wacker Drive, Suite 550, Chicago, Illinois 60606 ("Owner"), and any person claiming an interest in the land described below by, through or under Owner, and states:

That prior to and on July 26, 2000, and thereafter, Owner owned the land and all improvements thereon legally described on Exhibit A, attached hereto and incorporated herein, and commonly known as One North Wacker Drive, Chicago, Illinois ("Land"), Permanent Real Estate Index Numbers: 17-09-454-001, 17-09-454-002, 17-09-454-003, 17-09-454-004, 17-09-454-005, 17-09-454-006, 17-09-454-007, 17-09-454-008;

That on or prior to July 26, 2000, Owner or an authorized agent of Owner entered into a contract with the General Contractor for the construction of improvements on the Land,

including the construction of a building and appurtenant structures ("General Contract") and General Contractor was Owner's general contractor and/or agent for improvements on the Land;

That on or about July 26, 2000, General Contractor entered into a subcontract with Claimant to furnish all labor, materials, and services for the installation of stone and related work for the improvements and on the Land for the original amount of \$4,025,000.00("Subcontract"), which Subcontract was authorized or knowingly permitted by Owner;


That at the special instance and request of General Contractor, authorized or knowingly permitted by Owner, Claimant furnished extra and additional materials at and extra and additional labor on the Land at an agreed upon additional cost of \$552,507.00;

That on July 15, 2002, Claimant completed all of the work that it was required to perform under the Subcontract and all additional labor and services;

That after allowing all credits, there is the sum of \$78,721.00 due, unpaid and owing to Claimant, for which, with interest at 10% per annum, Claimant claims a lien in the amount of \$78,721.00 plus interest on said Land and improvements and on the moneys or other considerations due or to become due from Owner to General Contractor, against Owner and General Contractor.
