JOSEPH MATIELLO as Trustee, for the use and benefit of the legal holder of the notes secured by said
Trust Deed secondly herein described that the lien of the note owned by said ALLEN SHAPIRO and of
the ASSIGNMENT OF BENEFICIAL INTEREST securing the same shall be and remain at all times a
second lien upon the premises thereby conveyed subject to the lien of JOSEPH MATIELLO as said
Trustee as aforesaid for all advances made or to be made on the note secured by said last named,
JOSEPH MATIELLO, and for all other purposes specified therein.

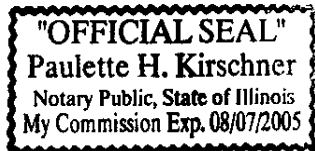
