SUBORDINATION OF MORTGAGE

1. Meadows Credit Union hereby irrevocably waives the priority of the Meadows Credit Union Mortgage in favor of the lien to FIRST SWITZERLAND FINANCIAL, ITS SUCCESSORS AND/OR ASSIGNS created by the FIRST SWITZERLAND FINANCIAL, ITS SUCCESSORS AND/OR ASSIGNS lien as to the Property, such that the lien of the Meadows Credit Union Mortgage shall be subject and subordinate to the lien of the FIRST SWITZERLAND FINANCIAL, ITS SUCCESSORS AND/OR ASSIGNS in the same manner and with like effect as though the FIRST SWITZERLAND FINANCIAL, ITS SUCCESSORS AND/OR ASSIGNS mortgage had been executed, delivered and recorded prior to the filing for record of the Meadows Credit Union Mortgage.
