ATTACHMENT TO ARTICLE 7
OF THE ARTICLES OF INCORPORATION OF
INTERNATIONAL FREIGHT INC.

7. Director Liability. No director of the corporation shall be personally liable to the corporation or its shareholders for monetary damages for breach of fiduciary duty as a director, provided, however, that this Article 7 shall not eliminate or limit the liability of a director (i) for any breach of the director's duty of loyalty to the corporation or its shareholders, (ii) for acts or omissions not in good faith or that involve intentional misconduct or a knowing violation of law, (iii) under Section 8.65 of the Illinois Business Corporation Act of 1983, or (iv) for any transaction from which the director derived an improper personal benefit. No amendment to or repeal of this Article 7 shall apply to or have any effect on the liability or alleged liability of ary director of the corporation for or with respect to any acts or omissions of of Cook County Clark's Office such director occurring prior to such amendment or repeal.
