5. My agent shall be entitled to reasonable compensation for services rendered as agent under this power of attorney.

6. This power of attorney shall become effective on October 8, 2002.

7. This power of attorney shall terminate upon the refinance, closing and end of three day right of rescision time period for the property described herein.

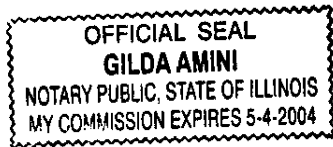


