Ontario Residential Condominium Association recorded October 6, 1999 in the Cook County Recorder's Office as Document No. 99947221 (the "Original Declaration"), as amended by that certain First Amendment to Condominium Declaration recorded December 13, 2001 as Document No. 0011182379 ("First Amendment"), as further amended by Second Amendment to Condominium Declaration recorded on October 8, 2002 as Document No. 0021164860 ("Second Amendment") (the "Declaration") and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in the Declaration for the benefit of the remaining property described therein.

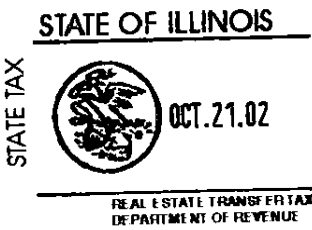

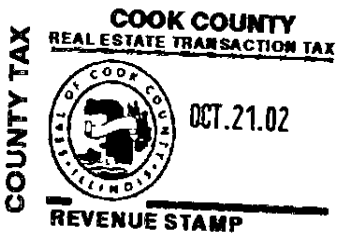

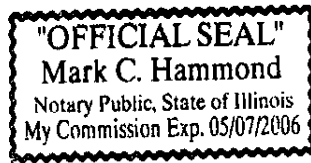
