
The premises shall be conveyed subject only to general real estate taxes not due and payable at the time of closing,

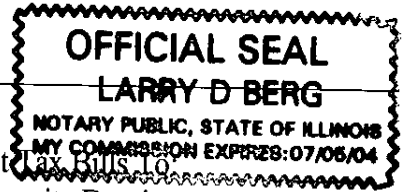

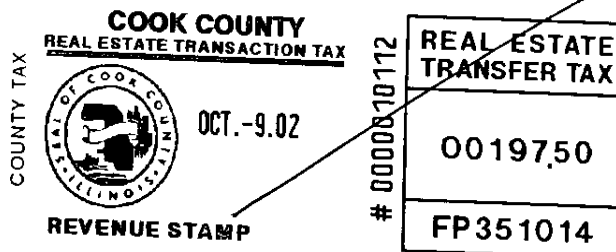
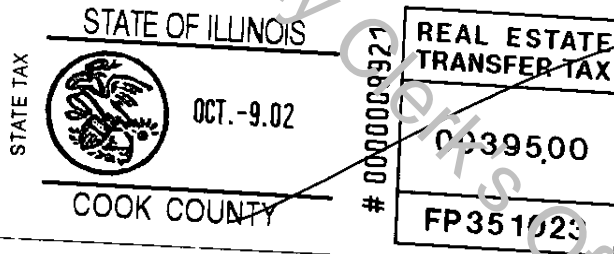
