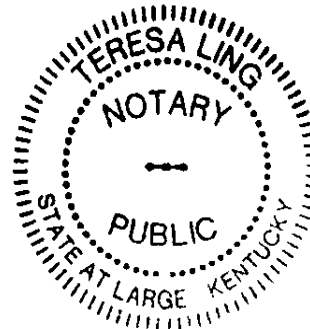

THIS MORTGAGE ("Security Instrument") is given on NOVEMBER 3, 1998 .

The mortgagor is Lyda E. Enriquez, UNMARRIED, ("Borrower").
